



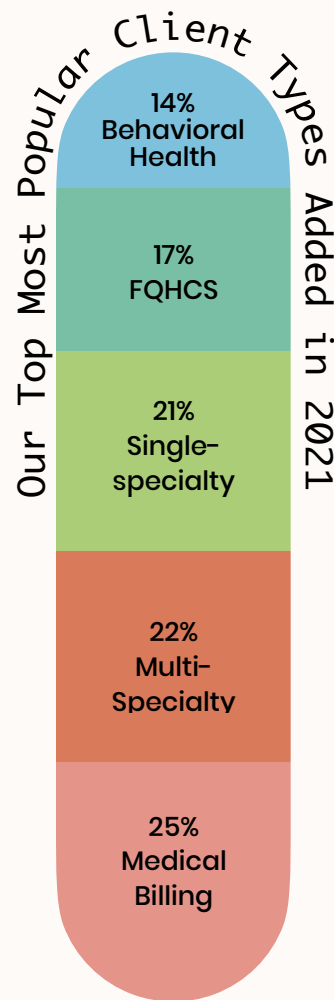
# A Look Back to Move Forward

## MODIO HEALTH 2021 YEAR IN REVIEW

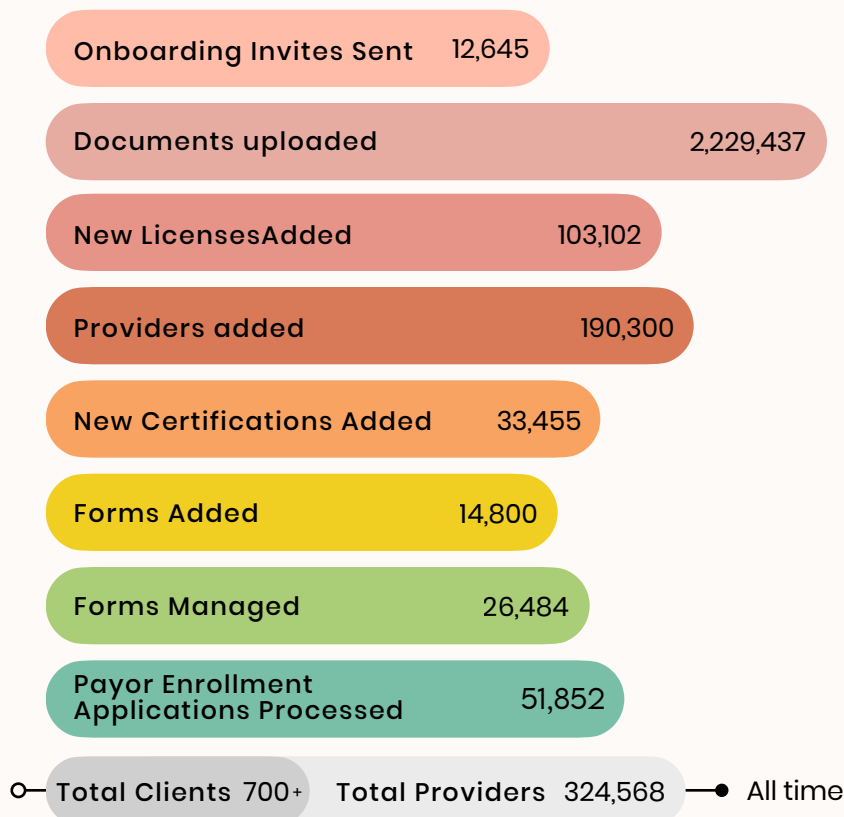

From the continued development of OneView 2.0 which was introduced to a handful of our clients as beta testers, to the addition of new verification features essential for our credentialing clients. Some feature highlights include:

- Easily adding providers using additional data integrations
- Customizing and resizing credentialing grids to help maximize screen-space and focus
- The ability to run up to 10 Carbon updaters at once
- Simplified management for a provider's verification record (add documents and notes, view statuses and hospital affiliations)
- Customizing what to include on a summary PDF of verifications
- View a list of all verifications completed for a provider and can customize fields and documents to be included in a summary PDF
- Navigation tabs which allow quick filtering for provider profile sections
- Compliance counts for expirables or issues in each grid
- A user facing audit-history to track team changes
- UX upgrades and performance enhancements

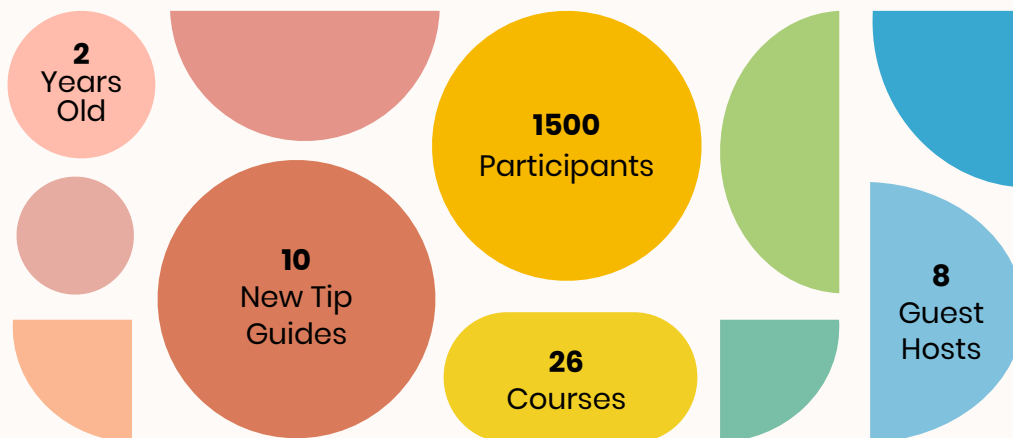

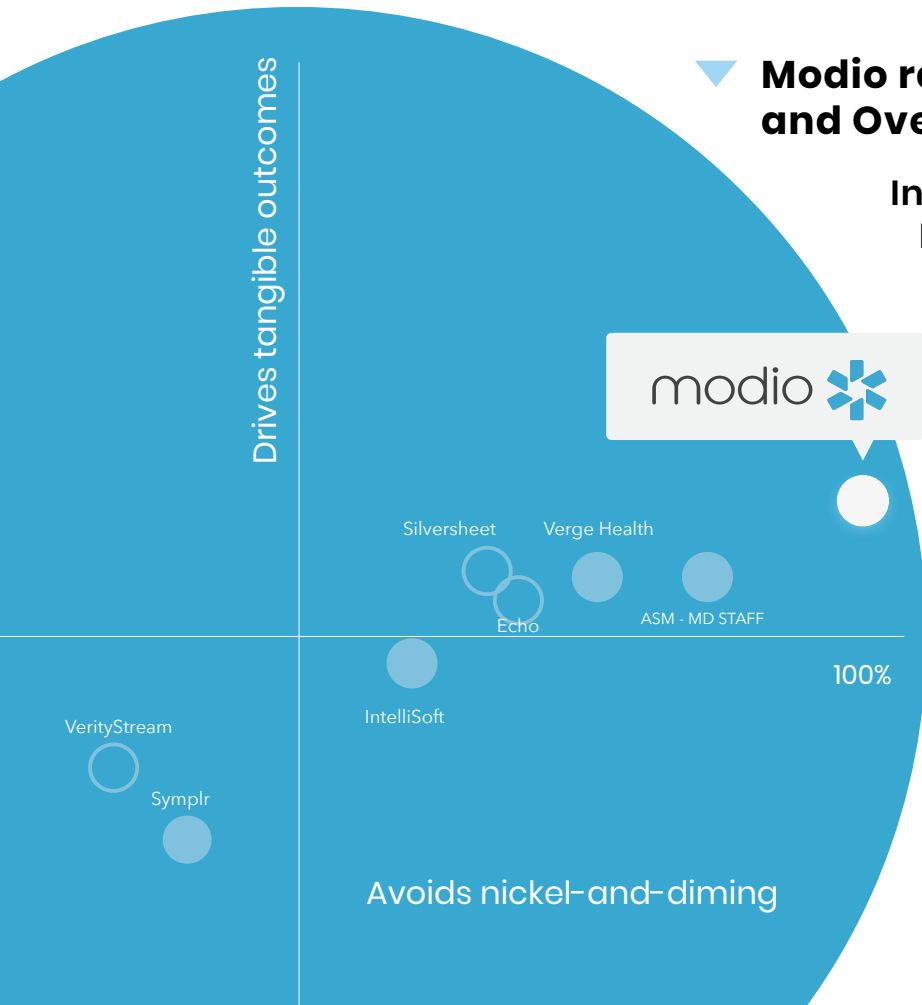
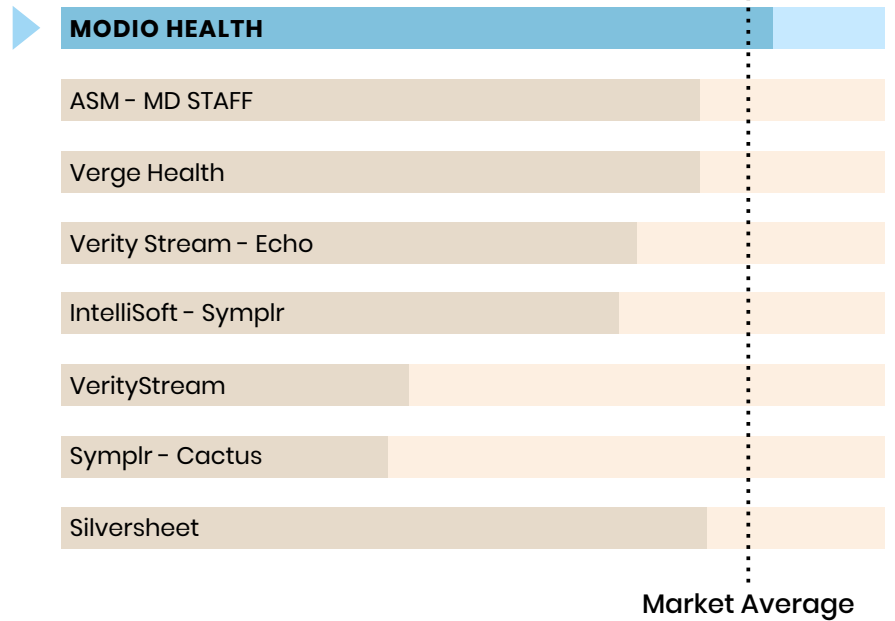
