
Overview

Since 2020, Modio has worked with USDOJ as a partner for verifying providers' DEA licensure via the OneView™ platform.






































To verify a provider's license with USDOJ, the following fields need to be present on the provider profile:

- Last Name (as it appears on your provider's DEA Registration)
- DEA Number

In addition to the USDOJ updater, our DEA Find Feature is available to identify additional DEA records. It uses only the provider's first and last name to search for possible license matches within the selected state. Double-check the DEA data returned against the provider profile, and/or manually verify a license in the online [USDOJ Validation Tool](#) to ensure that it belongs to the provider.
